Dear Rep. Luetkemeyer:

On behalf of the Community Associations Institute (CAI)¹, I am pleased to offer support for H.R. 3700, the Housing Opportunity Through Modernization Act of 2015. CAI members commend your leadership in the development of Title III of the Act, which will ease regulatory burdens and eliminate costly barriers to Federal Housing Administration (FHA) condominium project approval.

Condominiums are often the lower-cost housing option that meets the needs of first-time and minority homebuyers. Unfortunately, the majority of these households have been cut off from FHA programs due to an administrative misalignment that places greater emphasis on the bureaucratic process than responsibly achieving the Agency's housing mission or meeting constituent need.

By removing unnecessary and costly barriers to FHA condominium approval, more condominium households will benefit from lower housing costs through reduced FHA mortgage insurance premiums. This will have an important market impact not only in Missouri, where over the past two years 170 condominiums have allowed an FHA approval to expire, but across the country as well. That only 120 condominium projects in Missouri are currently FHA-approved illustrates the need for the regulatory relief H.R. 3700 will provide.

H.R. 3700 addresses the drastic runoff in FHA's condominium program by easing recertification burdens, granting HUD field offices autonomy over exemptions for commercial space, providing clarity on minimum owner

occupancy requirements, and harmonizing regulatory treatment of transfer fees. CAI members applaud these commonsense reforms that will prompt more condominium associations to seek and maintain FHA approval.
